**WORKING WORLDWIDE**

**When sending dung samples via Royal Mail or a courier service it is a legal requirement that the UN3373 mark below is attached to the outside of the package and clearly visible.**



**In order to comply with Royal Mail Postage Regulations please make sure you use the following guidelines:**

1. Your dung samples should be placed in a sealed leak proof plastic bag along with some absorbent material such as paper towel or cotton wool. Then transferred into a rigid and sealable plastic container, ideally a bio-bottle but a sandwich box or small ice cream container is suitable. It is a good idea to seal the edges of the container with tape.
2. Samples in plastic containers should then be wrapped with cardboard or paper wrapping. Bio-bottles should be sent within their outer cardboard box. At least one dimension of the parcel should be no more than 10 x 10cm. Ensure sure your submission paperwork is inside.
3. Address the parcel to the Veterinary Department at The Donkey Sanctuary and add the **UN3373** label above. You can cut it out and tape it to the parcel. Please remember this is a **legal requirement**.
4. If asked at the post office what is in the package, tell them that it is a **BIOLOGICAL SUBSTANCE CATEGORY B**.
